Meadow Farm Fell Ponies. "During the evaluation of the ponies. I explained to the audience how equine structural inte-

gration can help us to reach higher levels of elegance and grace in our horses in terms of their movement possibilities. I discussed how all horses, even healthy ones, can develop inefficient movement habits. Over time, the horse's body may begin to feel compromised in comfort and movement. The purpose of our body's connective tissue (or fascia) is to connect everything into one working whole. Ideally connective tissue is elastic and gel-like, allowing each neighbor, supporting and working in harmony with each other. But due to injuries, chronic stresses or strains, aging, and even normal wear and tear, the body's connective tissue (fascia) can thicken into adhesions as the tissue re-

pairs itself, often becoming fibrous and glue-like in the process. When connective tissue looses its natural flexible characteristics. movement of joints is reduced, muscles are prevented from lengthening to their full extent and thus fluid movement becomes compromised," Jackson said. When adhesions are present, it

may appear to the rider that the horse lacks flexibility or suppleness. Lack of connective tissue suppleness, could for example, be seen by a dressage rider as not easily being able to ride symmetrical figures, their lateral movements may not be symmetrical either. Hunter-jumper riders may experience difficulty maintaining straight lines while iumping a course or their horses may not round up their backs over jumps. Horses may even become irritable on the ground. During the demonstration, I explained to the audience how sessions can help horses organize themselves to

overcome road blocks which compromise their performance. The effects of Structural Integration Therapy are long-lasting because connective tissue is reprogrammed, it isn't just simply re-

"How is it accomplished? As it restructures and realigns the body, Structural Integration therapy can actually return connective tissue back to its former elastic, gel-like state. When chronic adhesions release their hold, the different layers of connective tissue (fascia) are able to glide effortlessly over one another. That is why it can be useful for rehabilitation therapy as well. A feeling of 'freedom of movement' emerges for us as riders. We can feel and see the changes in our horses as they can move more efficiently- freer and more powerfully. This translates into our horses having more potential energy, rhythmic grace and an increased willingness to perform along with the rider," she said.

On Nov. 4 Garland first met his young equine partner and he and the young gelding sized each other up, "He was blowing and snorting as we walked into the arena," said Garland. "I thought 'this guy is pretty nervous' and he gave every

indication that he could be on the verge of an impending explosion." Garland quickly gained the attention, and ultimately the trust,

of his young horse as the real work began. Working to establish forward movement at his direction, his horse was soon moving out on command or standing perfectly still at his direction. The end of day one saw a saddled horse with Garland quietly on his back. By day three his horse was standing unflinching as whips were cracked about his head and tarps were draped over his hindquarters while Garland rode him quietly around the arena.

The final obstacle course challenge on Sunday revealed a willing mount crossing obstacles, nudging a giant ball around the

arena, getting correct leads at the canter, and offering his rider complete cooperation.

This year's Challenge winner received a prize of \$1,000 from Presenting Sponsor Guardian Bedding and an exquisitely crafted quality built saddle from Circle Y Saddles and Champion Saddlery. Each contestant received a Spirit Horse sculpture from Mountain Feather Originals

press release from the township. The vote to condemn the property shocked Ludwigs Corner Horse Show Association members. The township claimed negotiations to buy the property failed but the association countered that the township did not respond to their offers to sell development rights for the land, one made three weeks before vote to condemn

playing fields for local youth sports but promised the Ludwies Corner Horse Show, held on Labor Day weekend, would be allowed to continue. The association was worried about what might happen to the smaller horse shows and dog events that are also are held on the grounds. "While the township's press release suggests they might continue this type of use, the West Vincent Master Plan indicates a significant portion of the property to be used as a commercial site." the association said in a press release sent out before the vote to rescind.

Residents and association members were relieved at the vote to rescind the original agreement. One woman described the condemnation as an abuse of power, and that it made no sense for the township to spend money on preserving the land as open space since that is the intent of the horse show association.
